

PRIVACY POLICY

Gift Me! is committed to protecting your personally identifiable information, and we appreciate you choosing to do business with us. This page describes our privacy policy which is included by reference in our Registrant Terms of Use Agreement, Guest Terms of Use Agreement, and Vendor Terms of Use and Advertising Agreement. By visiting Gift Me!'s website, you accept the practices described in this Privacy Policy.

A. Personal Information Gathered By Gift Me!

Gift Me! collects your personal and business information when you register for a User account in order to utilize the services offered by the Site. During registration, we ask that Registrants provide us with information to include the following: (i) first and last names of couple getting married, (ii) address, (iii) telephone number, (iv) email address, (v) wedding date, and (vi) geographic wedding location. We ask Guests to provide us with (i) first and last name, (ii) address, (iii) telephone number, (iv) email address, and (v) first and last names of couple getting married. We ask Vendors to provide us with (i) first and last name, (ii) company name, (iii) products and services offered, (iv) address, (v) telephone number, and (vi) email address.

The information we obtain from Users allows for User connection, and may also be used for such purposes as responding to your requests, customizing our services, improving future services, improving our business, and communicating with you. We receive and store any information you enter on our Website or give us in any other way. You may choose not to provide us with certain information. However, choosing to withhold information may result in an inability to register an account with the Site.

We do not allow User registration for persons under the age of 18. Should we find User account for someone under the age of 18, we will immediately terminate the account and delete the User information. Gift Me! will not be held liable for any content, posts, or advertisements viewed by persons under the age of 18, in violation of this Privacy Policy.

We may also receive and store certain types of information when you interact with us. For example, like many websites, we may use "cookies," which are to obtain certain types of information when your Web browser accesses the Website. To help us make e-mails more useful and interesting, we may receive a confirmation when you open e-mail from us if your computer supports such capabilities. **If you do not want to receive e-mail or other mail from us, please follow the unsubscribe instructions at the bottom of any e-mail message you receive from us.** We also use cookies to help us identify you as a user and provide you with access to your personal account. Please understand that if you do not allow your browser to accept cookies, you may limit the functionality of and your access to the site.

B. Information Sharing.

By registering for an account, you are agreeing to make certain information such as name, telephone number, and email address, visible and public so that other Users can access the information.

We do not share your information unless it is reasonably necessary for the functionality and efficiency of the Site and including, but not limited to the reasons herein. As we continue to develop our business, we may sell or purchase other companies, subsidiaries, or business units. In such transactions, your information will typically be one of the transferred business assets. Also, in the unlikely event that we, or substantially all of our assets are acquired, User information will be one of the transferred assets.

We release account and other personal information when we believe release is appropriate to comply with the law; enforce or apply our Registrant Terms of Use Agreement, Guest Terms of

Use Agreement, Vendor Terms of Use and Advertising Agreement, and any other agreements; or protect the rights, property, or safety of Gift Me!, Site Users, or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction.

C. Information Security

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input. We reveal only the last five digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing.

D. Third-Party Advertisers And Links to Other Websites

Our site may include third-party advertising and links to other websites. These third-party websites and advertisers, or Internet advertising companies working on their behalf, sometimes use technology to send (or "serve") the advertisements that appear on our website directly to your browser. They automatically receive your IP address when this happens. They may also use cookies, JavaScript, web beacons (also known as action tags or single-pixel gifs), and other technologies to measure the effectiveness of their ads and to personalize advertising content. We do not have access to or control over cookies or other features that they may use, and the information practices of these advertisers and third-party websites are not covered by this Privacy Policy.
